

EARL ETHERIDGE EXCELLENCE IN OFFICIATING AWARD

The Earl Etheridge Award is given to an official that truly has shown excellence in this business, and has done more than just officiate his or her games. Earl Etheridge is an individual that has exhibited professionalism as a coach, as a father, and especially as the Director of Savannah Parks and Recreation Services. Earl has improved conditions for officials by leaps and bounds in his relationship with the GAOA, and we will never be able to pay him back for his support and friendship. This award represents 2015's Overall Official of the Year, and is the highest award given by the GAOA.

JIM SNEDDON

Jim Sneddon, veteran baseball and softball umpire has received this prestigious award for his incredible work in umpire training and his leadership abilities with the GHSA.

he GAOA is pleased to announce that the Earl Etheridge Excellence in Officiating Award Overall Official of the Year for 2015 is Jim Sneddon of Carrolton, Georgia. A 32-year veteran umpire and a leading figure in GHSA baseball and softball, Sneddon has also earned appearances in A-SUN, ACC, and SEC competitions. Sneddon is currently the acting Baseball liaison and Umpire in Chief (UIC) for softball state tournaments with the GHSA.

Sneddon brought his enthusiasm for and knowledge of fast-pitch softball and baseball from Indiana to Georgia in 1983. After years spent garnering the respect and appreciation of his peers through his fine work, Sneddon became integral to overseeing softball's conversion from slow- to fast-pitch in Georgia, a change that kept state athletes competitive for college scholarships in the sport. He has worked multiple state championships in both softball

and baseball, and has been instrumental in opening up the same opportunity to a wider pool of officials and Associations through his innovative measures in the administration and scheduling of playoff and championship series throughout the state.

Reflecting on his career and his reception of this award, Sneddon affirmed, "Softball and Baseball have been real good to me. You meet a lot of good people. It keeps you young running around out there and interacting with the kids. My wife tells me I never really retired – I just changed professions. You try to put back into the game. My goal is to make officiating better – to help put better umpires on the field."

Chip Huffman has been selected for the Charlie Bloodworth Lifetime Acheivement Award. His leadership on and off the field and court has truly benefited all who know him.

his year's recipient of GAOA's Charlie Bloodworth Lifetime Achievement in Officiating Award is Chip Huffman of Augusta, Georgia. During his impressive 35-year career, Chip Huffman has become a decorated football and basketball official, having worked multiple GHSA state championship football and GISA state championship basketball contests.

Huffman attributes his early interest in officiating to his father, who was also an official and lifelong supporter of Huffman's passion for the profession. Huffman began officiating at the age of 16, working recreation league games until beginning to officiate GHSA events in 1980. Currently, he serves as the Assigning Secretary for the Augusta Football Officials Association. A father of three, Huffman describes himself as "blessed" to have also passed on an enthusiasm for officiating to a son. "I'm blessed to have a 25-year-old son doing well in officiating alongside me. It's really special to

get to work with him on Friday nights." Huffman also credits the camaraderie of fellow officials and coaches with his enduring enjoyment of officiating. "My dad had a saying that's true for me too," Huffman recalls, "I've made a lot more friends officiating than I have enemies."

In speaking of his reaction to this award, Huffman described himself as "overwhelmed." "It makes me think of my dad," Huffman states, "learning from my dad, passing it on to my son — I know he's proud of me up in heaven." Huffman went on to reflect on the hard work required to excel as an official. "I've dedicated a lot of nights to officiating sports and I love it. It is rewarding to be recognized for all this hard work. The average fan has no idea the time we put in to prepare for seasons and games, and it's a heartwarming honor to be recognized like this by your peers.
